

# Recreational Marine Driver/Personal Watercraft Licence or Marine Licence Indicator Application



Transport Operations (Marine Safety) Act 1994

This form may be used to apply for a—

- Recreational marine driver licence;
- Personal watercraft licence.

## Recreational Marine Driver Licence (RMDL)

To apply for a RMDL, you **must** be at least sixteen (16) years of age and be able to produce evidence that you have one of the following—

- successfully completed a Department of Transport and Main Roads (the department) approved course of training/assessment;
- a current equivalent interstate recreational marine licence;
- a current Queensland (Qld), interstate or Australian Maritime Safety Authority (AMSA) marine licence to operate a commercial or fishing ship as its master.

## Personal Watercraft Licence (PWCL)

To apply for a PWCL, you **must** be at least sixteen (16) years of age, hold a valid RMDL or recognised equivalent marine licence and be able to produce evidence that you have one of the following—

- successfully completed a department approved course of training/assessment;
- a current equivalent interstate personal watercraft licence.

You may also use this form:

- to apply for a marine licence indicator if your Qld driver licence indicated that you hold a PWCL or RMDL and the driver licence has been cancelled or surrendered;
- if you are applying for the issue of a marine licence indicator because you hold a PWCL or RMDL but do not hold a Qld driver licence;
- if you are applying for the further issue of your marine licence indicator because the card has expired

**NOTE:** If you hold a Qld driver licence, a marine licence indicator will be added to your driver licence. If your Qld driver licence is currently suspended you will not be eligible for a driver licence with marine licence indicator until your driver licence suspension period has ended. Once your suspension is complete you may apply for a replacement driver licence with marine licence indicator.

## Personal Identification Number (PIN) and Shared Secrets

To record your PIN or Shared Secrets on your licence, please complete the *Personal Identification Number and Shared Secrets Application* (form F4748).

### Evidence of identity (EOI) requirements

You **must** give evidence of your identity at the time of making this application. You may do so by presenting your **Qld driver licence**. If you are unable to present your driver licence, your Qld industry authority, marine licence indicator or adult proof of age (APA) card may be accepted (conditions apply).

If you are unable to present any of these documents you will need to present **three (3)** EOI documents. These documents must include at least one **Category A** document and one **Category B** document. The third document may be from either category, however, one of these documents must include your signature.

All documents must be current or expired less than 2 years. All documents must be original documents. **Photocopies and certified copies of original documents are not acceptable.**

### Change of Name Requirements

If you have changed your name or the details of your name are different on the documents provided, you **must** show a change of name document from the relevant Australian Registrar of Births, Deaths and Marriages (BDM).

### Digital Photo

You may be required to allow the taking of a digital photo to confirm your connection to the most recent digital photo kept by the department or to renew the latest digital photo.

# Recreational marine driver licence and personal watercraft licence – medical fitness disclosure statement

The following process will apply if a medical condition or other impairment is declared:

- The BoatSafe training provider must refer the matter to Maritime Safety Queensland (MSQ) along with the licence candidates contact details for a medical fitness review.
- MSQ will contact the candidate to provide details of the medical fitness review process and associated requirements.
- If agreed by the BoatSafe training provider, the candidate may to continue with their BoatSafe training and assessment.
- Satisfactory resolution of their medical fitness review and a BoatSafe 'Statement of Competency' are prerequisites for the granting of a marine licence.
- A marine licence may be granted or refused by MSQ only after the above processes have been successfully completed and reviewed.
- MSQ may impose restrictions/conditions on the licence if it is granted.
